Order was issued from the Public Works Department, Government of West Bengal regarding monthly amount of expenditure that can be incurred in respect of hiring of inspection vehicles by the different Circles/Divisions/Sub-Divisions under the Public Works Department (Roads Wing) including the vehicles of Chief Engineers which was upto Rs.25,000/-(Rupees twenty five thousand) only vide erstwhile Memo No.(s) 628-R/E pt. 05.05.2015.

- 2. Now after careful consideration of the issues of exigencies of the various Circles/Divisions of the Public Works Department (Roads Wing), the Governor is pleased to raise the earlier sanctioned amount from Rs.25,000/- (Rupees twenty five thousand) only per month as per following scales:
  - a) For Chief Engineers of the Zones / Head Quarters: Raised to Rs.35,000/- (Rupees thirty five thousand) only per month.
  - b) For Superintending Engineers of \_\_\_\_\_ Circles: Raised to Rs.35,000/- (Rupees thirty five thousand) only per month.
  - c) For Executive Engineers of National Highway Division V: Raised to Rs.30,000/- (Rupees thirty thousand) only per month.
- This order will become operational w.e.f. 01/10/2015.

# MEMORANDUM

The detailed procedure of works and forest expenditure has already been prescribed vide F.D. Memo No. 736-F(Y) dated 10.02.2015 read with 2705-F(Y) dated 30.03.2015, consequent upon switch over from LOC system of drawal of fund related to works and forest expenditure to bill system of drawal of fund from treasury w.e.f 01.04.2015.

Although use of vehicle is necessary for supervision of works, the procedure of drawal of expenditure related to inspection vehicles is not mentioned in the above mentioned Government orders. Inspection vehicles being closely related to the departmental function of this department, it is felt that engagement of vehicles for inspection of works without disturbing the work itself is very much necessary.

After careful consideration of the matter, sanction is hereby given with effect from 01.04.2015 for continuance of hiring of 04 nos. of vehicles for Executive Engineer, National Highway Division No.-V, which are already in operation, for inspection of works undertaken by the Division subject to availability of necessary fund under the object head "19-Maintenance" subordinate to functional heads of account for revenue expenditure related to works. The total expenditure for each car per month shall be limited to Rs. 25,000/- which shall be inclusive of Hiring charges, Fuel consumption & Mob Oil consumption and Additional charges beyond 10 hours.

In case of journeys made by the concerned officers on holidays for official purpose a certificate shall be furnished on the body of the bill by the concerned DDO that the journey was performed in the interest of public service and no separate sanction from higher authority will be required for such journey on holidays.

Such claims shall be drawn by submission of bill in TR form no. 26 to the treasury/PAO.

This order issues with the concurrence of the Finance Department vide U.O. No. Group-T/2015-2016/0001 dated 01.04.2015.
