## MEMORANDUM

In continuation to this Department's Memo No. 1M-10/15/601-R/E dated 05.05.2015 reflecting this Department's decision over the hiring of 296 numbers of vehicles for the inspection purpose undertaken by various divisions and Circles under the auspices of this Department, These number of vehicles were subsequently disbursed over to the regional offices, who had been using the vehicles for official purpose.

- 2. However, in case of the office of Executive Engineer, National Highway Division VIII, Uttar Dinajpur, who has also been engaged in P.M.G.S.Y work, no vehicle was allotted for inspection purpose to them since 01.04.2015. The matter of approval of that single vehicle for the purpose has been under the serious consideration of this Department since past.
- 3. Therefore, the undersigned is directed to say that the Governor has been pleased to accord post-facto approval to sanction one (01) number of vehicle since 01.04.2015 for the official use of the Executive Engineer, National Highway Division No. VIII for P.M.G.S.Y work & inspection of works undertaken by the Division subject to availability of fund under the object head "19-Maintenance" subordinate to functional head of account for revenue expenditure related to works.
- 4. The total expenditure for each vehicle for each calendar month shall be limited to ₹ 25,000/- till the month of September 2015 and ₹ 30,000/- since 01.10.2015, which shall be inclusive of hiring charges, fuel consumption & Mobil oil consumption and addition charges beyond 10 hours in conformation to Transport Department's Notification No. 3564-WT/2M-81/98 dated 24.11.2008,
- 5. In case of journeys made by the concerned officers on holidays for official purpose a certificate shall be furnished on the body of the bill by the concerned DDO that the journey was performed in the interest of public service and no separate sanction from higher authority will be required for such journey on holidays.
- 6. Such claims shall be drawn by submission of bill in TR form no. 26 to the respective treasury/PAO.
- 7. This order issues with the concurrence of the Finance Department's U.O No. Group T/2015-2016/0001 dated 01.04.2015 followed by Group T/2015-2016/0947 dated 10.02.2016.
